Assessment of degree of rusting

1 Scope

This part of ISO 4628 specifies a method for assessing the degree of rusting of coatings by comparison with pictorial standards.

The pictorial standards provided in this part of ISO 4628 show coated steel surfaces which have deteriorated to different degrees by a combination of rust broken through the coating and visible underrust.

NOTE 1 The pictorial standards have been selected from the "European rust scale" published by the European Confederation of Paint, Printing Ink and Artists' Colours Manufacturers' Associations (CEPE), Brussels. The correlation between the ISO scale and the "European rust scale" is given in Annex B, Table B.1.

NOTE 2 The correlation between the ISO scale and the rating system of ASTM D 610 is given in Annex B, Table B.2.

NOTE 3 The rust formation on uncoated steel surfaces is designated in accordance with ISO 8501-1 (rust grades A, B, C, and D).

ISO 4628-1 defines the system used for designating the quantity and size of defects and the intensity of changes in appearance of coatings and outlines the general principles of the system. This system is intended to be used, in particular, for defects caused by ageing and weathering, and for uniform changes such as colour changes, for example yellowing.

3 Terms and definitions

For the purposes of this document, the following terms and definitions apply.

3.1

degree of rusting

Ri

rating characterizing the degree of rust formation (rust broken through and visible underrust) on a coating

Assessment

Assess the degree of rusting (Ri) on a coating by means of the pictorial standards given in Figure 1 to Figure 5. The approximate areas rusted (rust broken through plus visible underrust) shown on these standards are as indicated in Table 1.

Procedures for assessing invisible underrust, if required, shall be agreed between the interested parties.

loeg.co. Where different degrees of rusting occur in different parts of the area being assessed, indicate these degrees of rusting together with the part where each occurs.

Carry out the assessment under good illumination, as specified in ISO 13076.

If the average size of the rust spots on the test area differs considerably from those shown in the pictorial standards, an indication of their size may be given by reference to ISO 4628-1:2015, Table 2.

The pictorial standards are basically intended for assessing the degree of rusting of coated steel. They can be used for designating the degree of corrosion of coated non-ferrous metals if the form of breakdown is comparable with that shown in the standards.

If the assessment is to be done by an optical imaging system, calibrate the system using the images given in Annex A.

Expression of results

Express the degree of rusting as Ri class as shown in Figure 1 to Figure 5

If applicable, indicate the different degrees of rusting obtained, together with the parts of the test area concerned.

If applicable, indicate the degree of rusting Ri together with the numerical rating of the size of the rust spots.

For example, if the rusted area corresponds to Figure 3, Ri 3, and the sizes of the individual rust spots are between 0,5 mm and 5 mm, report the result as

rusting; degree of rusting Ri3 (S4).

Test report

The test report shall contain at least the following information:

all details necessary to identify the coating examined;

When measuring the rusted area in Figure 4.5, it is only about 35 %. If rust is assessed visually using Figure 5, the impression of rusted area is 40 % to 50 %. One reason might be that partly delaminated rust flakes are not distinguished from other rusted areas. But this is negligible because R15 normally is outside any specification.






Figure A.5 — Degree of rusting Ri 5

Textiles — Determination of dimensional change in washing and drying

1 Scope

This International Standard specifies a method for the determination of the dimensional change of fabrics, garments or other textile articles when subjected to an appropriate combination of specified washing and drying procedures.

In the case of textile articles or deformable materials, it is necessary to exercise all possible caution in the interpretation of the results.

2 Normative references

The following referenced documents are indispensable for the application of this document. For dated references, only the edition cited applies. For undated references, the latest edition of the referenced document (including any amendments) applies.

ISO 139, Textiles — Standard atmospheres for conditioning and testing

ISO 3759, Textiles — Preparation, marking and measuring of fabric specimens and garments in tests for determination of dimensional change

ISO 6330, Textiles — Domestic washing and drying procedures for textile testing

3 Principle

The specimen is conditioned in the specified standard atmosphere and measured before subjection to the appropriate washing and drying procedures. After drying, conditioning and remeasuring of the specimen, the changes in dimensions are calculated.

4 Apparatus and reagents

Use apparatus and reagents as specified in ISO 3759 and ISO 6330

5 Atmospheric conditions

The atmospheric conditions required for conditioning and testing are specified in ISO 139.

6 Test specimens

- 6.1 The selection, dimensions, marking and measuring of test specimens are specified in ISO 3759.
- **6.2** When possible, three specimens from each sample should be used. One or two specimens may be used when insufficient sample is available.

Procedure

- 7.1 Determine the original length and width dimensions, as appropriate, after the specimens have been conditioned and measured according to the procedure specified in ISO 139 and ISO 3759.
- 7.2 Wash and dry the specimens according to one of the procedures specified in ISO 6330, as agreed between the interested parties.
- 7.3 After washing and drying, condition and measure the specimens and calculate the dimensional change of the specimens according to the procedure specified in ISO 3759.

Expression of results

8.1 Calculate the mean changes in dimensions in both the length and width directions in accordance with the arrangement in ISO 3759 as follows:

$$\frac{x_{\mathsf{t}} - x_{\mathsf{o}}}{x_{\mathsf{o}}} \times \mathsf{100}$$

where

- is the original dimension; x_{0}
- is the dimension measured after treatment.

Record the changes in measurement separately as a percentage of the corresponding original value.

- 8.2 Express the average dimensional changes to the nearest 0,5 %.
- Will Harry Coll. 8.3 State whether the dimension has decreased (shrinkage) by means of a minus sign (-) or increased (extension) by means of a plus sign (+).

Test report

The test report shall specify the following:

- a) the number and year of this International Standard;
- b) the number of specimens washed and dried;
- the procedure used for washing and drying from ISO 6330; C)
- for fabric specimens, the average dimensional change in the length (warp or wale) and the average dimensional change in the width (weft or course) to the nearest 0,5 %;
- for garments, the description, make and size of the garment tested;
- for garments, an adequate description of each measuring position and the average dimensional change to the nearest 0.5 % at each position for each garment tested.
